The recent informational letter 2480-MC-FFS released on June 27, 2023 announced reporting changes for critical (major) incident reporting for all HCBS waiver, habilitation, and MFP members. The "Incident Report User Guide" in the Iowa Medicaid Portal Access (IMPA) was updated in June to prepare for these changes. The new direct entry reporting form was effective July 1, 2023 and the HCBS Quality Improvement Organization (QIO) will be holding the upcoming virtual training session to address the new form and relevant instructions:
